Ordinary Meeting of **Ainstable Parish Council** held in Croglin Village Hall at 7:30pm on Tuesday 15 July 2014.

## **MINUTES**

**Present**: Cllr Thirlwall (Chaired the meeting), Cllr Bellis, Cllr Guise, Cllr Findlay, Cllr Miller, Cllr Little & Cllr Ritchie (was co-opted on).

1. **Open Meeting** - for discussion of matters of general parish concern- No points raised.

#### **Parish Council Meeting**

- 2. **Declaration of interests** None
- 3. To receive apologies for absence- Cllr Vear, Cllr Collinge & Cllr Smith
- 4. To resolve to accept the minutes of the following meeting as a true record:
  - a. The last ordinary meeting held on Tuesday 20 May 2014- It was resolved to accept the minutes (proposed by Cllr Guise, seconded by Cllr Bellis, unanimous vote).
- 5. <u>To discuss the co-option of new councillors</u>- After discussion and clarification of the procedure by County & District Cllr Robinson, Mrs Angela Ritchie agreed to be co-opted onto the parish council (proposed by Cllr Little, seconded by Cllr Guise, unanimous vote).
- 6. Report from attendance at outside bodies- It was reported that Cllr Collinge and Cllr Vear had attended a C.A.L.C. meeting on 8<sup>th</sup> July, 2014.
- 7. <u>To receive a report on crime in the Parish</u>- Although there is nothing recorded on the Police website, it was reported that there had been some poachers in Crogin area collecting dead rabbits that had been killed on the road.
- 8. <u>To discuss any Highways matters arising</u>- Most points already covered. It was noted that there are potholes on the corner and also outside the church in Ainstable.
- 9. <u>To receive an update on the repair of traditional road signs in the Parish</u>- It was reported that the new sign post at Ainstable crossroads will be installed on Thursday 17<sup>th</sup> July. Councillors agreed that it would be good to organise some media attention to highlight the work carried out and provide a chance to thank those who have made grants towards the project.
- 10. <u>To receive a report on the Millennium Green</u>- The Clerk reported that she had received a statement giving the balance in the COIF account. She said that she had also received a cheque for the closing balance of the Barclays account and it was agreed that this also be paid into the COIF account.
- 11. <u>To receive an update on Croglin Educational Foundation</u> Cllr Thirlwall reported that there had been four applications for grants and these have been made. The Foundation has also provided a trophy to William Howard School to be awarded to an outstanding pupil and some prize money donated for children's races at Croglin Sports Day.
- 12. To receive an update on special projects:
  - a. Newbiggin bus shelter- It was reported that the shelter is to be installed in July/ August.

- b. Newbiggin bench- It was reported that the new bench in Newbiggin has been installed and it was agreed to carry out a survey into the condition of other parish benches. It was agreed to obtain a quote for those needed. It was noted that in Croglin the new telegraph pole would need to be moved to allow a replacement bench to be positioned there.
- c. Parish noticeboards- ongoing fundraising for these to be renewed in due course.
- d. Flooding in Croglin- The minutes of the recent subcommittee meeting have been forwarded to the Clerk. It was agreed that she send a formal letter to Helen Renyard asking for urgent action with a subsequent letter to the Chief Executive if nothing is forthcoming.
- 13. <u>To discuss dog fouling in villages</u>- Cllr Findlay reported that some warning letters had been issued to offenders with leaflets circulated to all households in Ainstable village. It was agreed that some extra warning signs be placed in the village.

### 14. To discuss any matters relating to communications

- a. Website- Cllr Bellis reported that the website design has now updated and is clearer and easier to read. Councillors were asked for photos of the area to be included on it.
- b. Parish news- Cllr Smith organises the inclusion of Parish Council details in the Parish News but was unable to attend the meeting. Cllr Guise reported that there were no meeting times in the last copy and it was agreed that the Clerk report this to Cllr Smith.
- c. Newsletter- Cllr Vear asked for stories to be included in the September copy.
- d. Parish File- the Clerk reported that it was up to date.

- Cllr Little asked that an extraordinary meeting be held should an application to convert the church in Croglin be made.
